What is the AIG Construction Claims Promise?

The estimate is to be agreed between the policyholder, broker and the AIG representative, based upon reasonably available information. This payment is made on an unallocated basis.

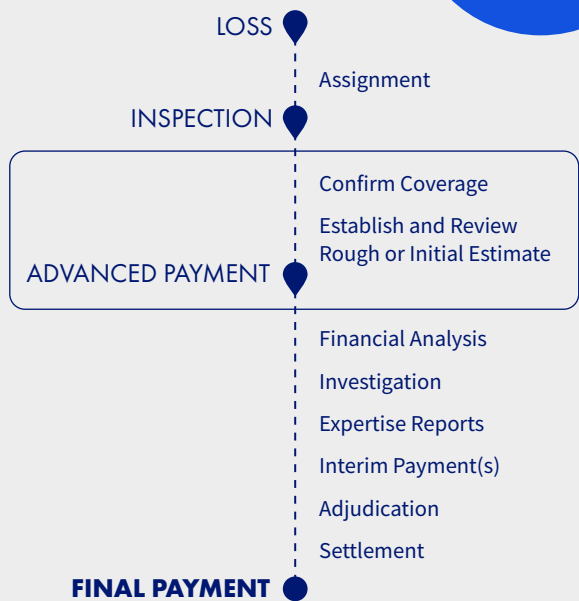
How is the loss estimate determined?

The AIG representative is to ensure that the coverage applies and that the initial loss estimate is reasonable. The advance of funds under the AIG Construction Claims Promise is not made against loss of income/delay in start up and is for physical damage only. It is AIG's intent to provide working capital to our insured to help commence repairs.
